Dear Minister,

In view of the ongoing discussions and the upcoming Council meeting on the social and market aspects of the Mobility Package I, we, the road transport and logistics companies in Denmark, Sweden, Norway, Germany, France, Netherlands, Belgium and Italy would like to highlight the following points:

<u>In our joint statement from June 2017</u> we argued that the main objective for revising the rules for the internal market for road transport should be to create sound and fair competition between operators in the EU. But we also made it clear that to reach that goal we need:

- clear, uniform and unambiguous rules and interpretation of EU legislation
- effective, proportionate, uniform, cooperative and harmonized enforcement
- a better work environment with good infrastructure of high quality for drivers, secured parking places with decent sanitation services, terminals, loading stations.

Even though today's situation seems to be difficult to find compromises, we firmly believe in common EU rules to avoid a patchwork of national schemes, unnecessary administrative burdens and legal uncertainty as well as unfair competition for hauliers.

We, therefore, favor agreements taking into consideration the following aspects:

<u>Posting</u>

- <u>We favor</u> a solution that accepts the general approach by the **Commission proposal** as a starting point and which includes international transport in the "lex specialis" directive.
- <u>We support</u> approaches on targeted checks on compliance with the **working time directive** at the premises, better **exchange of information** between member states with a tighter time schedule to deal with enforcement requests from another Member state, the inclusion of the transport leg in a **combined transport** operation in the posting directive and the request for a **posting declaration** for each transport operation.
- <u>We disagree strongly with any rule which excludes a large part of the road transport activities</u> from the "posting" directive.

Driving and rest time

• <u>We agree</u> with the requirements for a transport operator to enable drivers to return home regularly to combat driver's nomadism (enhances a better work-life-balance). <u>We support</u> rules prohibiting drivers from taking the regular weekly rest in the **cabin** unless they are taken in secured parking areas (improves the social standards of drivers) fulfilling high and verifiable criteria and only in relation with a "return home" after 3 weeks. <u>We agree</u> with more flexible rules on breaks, additional two hours of driving in exceptional cases when returning "home" (increases the driver's comfort to reach home and spend rest periods at home), support an ambitious and differentiated introduction of the "Smart tachograph", ideally avoiding the introduction of the 1st generation to start directly with the 2nd generation of the "Smart tachograph".

Access to market and profession

- <u>We disagree</u> with any <u>liberalization of cabotage</u> operations until a convergence of social standards is achieved and underline the <u>temporary nature</u> of cabotage operations. The new rules must emphasize this temporary nature of cabotage. <u>We warmly</u> welcome the inclusion of <u>vehicles from 2,4t</u>, better use of **ERRU** by enforcement authorities and adding "cabotage" and "fair competition" to the criteria concerning the loss of **good repute**.
- <u>We suggest</u> a more precise wording to differentiate better between the freedom to provide service and the need to establish in a country from which the main activities start.
